The Fazaia Medical College and its teaching hospitals (PAF Hosp Unit-I & II) are duly recognized by the Pakistan Medical Commission, for MBBS program. FMC invites applications from fresh MBBS graduates for structured House Job/ Internship - 2021 as per following schedule: -

Terms and Conditions

1. Selection
 - 1st Preference: MBBS graduates of Fazaia Med College (FMC), Islamabad.
 - 2nd Preference: MBBS graduates of public sector Med Colleges.
 - 3rd Preference: MBBS graduates of private sector Med Colleges.
2. Internship will be subject to availability of seats.
3. Payment of stipend to the House Officers from Med colleges other than Fazaia Med College (if selected) will be responsibility of the parent Institution (from where he/she passed MBBS).
4. The house job will be 24 hours round the clock and the House Officers will be bound to perform duty as per assigned duty schedule.
5. Two days casual leave per month (but not more than 7 days in 6 months) will be entitled subject to availability of standby substitute, recommendation of the head of concerned department and approval by the Chairman House Job Committee, FMC. Stipend will be deducted for casual leaves beyond two days per month.
6. The house job will be liable to suspension/termination in case of misconduct or absentee for no reason beyond seven days.
7. Leave granted for Medical/Maternity (ante/post-natal)/Marriage/Umrah/Hajj etc. for more than seven days (if approved) will be considered as frozen period of the house job and its completion in the respective departments will be mandatory for issuance of the house job certificate at the end of one year.
8. Any candidate convicted by the Court of Law (before/during internship) will not be considered for house job at FMC.
9. Application on prescribed forms (complete in all respects) along with attested documents must reach office of the undersigned on or before the closing date. After the closing date, application will neither be received nor entertained. If there is public holiday on the closing date, the next working day may be considered as the closing date.
10. Application Forms can be downloaded from official website of the FMC Islamabad i.e., www.au.edu.pk.
11. Provisional registration of the candidate with PMC, applying for house job and permanent registration of his/her parent Medical College with the PMC is mandatory.
12. Institutional house job committee will be authorized to accept/reject any application during scrutiny of the documents or interview/selection.
13. In case of any discrepancy/anomaly in the selection process, or in matters pertaining to leave, absentee, or issuance of certificate to the house officer, the decision of the Chairman, Monitoring & Certification Committee of House Job shall be final.
14. In case of selection, the house officer will be required to submit an undertaking as per specimen provided by the FMC on judicial stamp paper of Rs. 100/- duly attested by the Oath Commissioner/Notary Public along with one guarantor (parent/guardian) and two witnesses.
15. No migration/shifting/transfer from one department/institute to other department/institute will be allowed after selection of the house officers.
16. No TA/DA shall be admissible to the candidates for attending Interview.
17. Concealment of facts or forging/tampering of documents on the part of candidates will lead to legal proceedings against them and termination of the house job at any stage.
