A wellformulated research question identifies the problem or issue to be studied and provides a clear purpose for the research.

8. Research Methodology

It refers to the approach and techniques used to investigate the research question or hypothesis. It outlines how data will be collected, analyzed, and interpreted to achieve the study's objectives.

Data

This section will outline the specification of the data sets consumed to conduct the study. Types of data such as primary or secondary along with identification of source are required for this section.

Analysis

This section will identify the research technique used to analyze the data sets.

Outline factors that could constrain the scope, accuracy, or generalizability of your study, which may involve methodological constraints, sample size, data collection issues, or external factors beyond your control.

12. Ethical Considerations

It will address the principles and practices to ensure the research respects human rights, integrity, and academic standards. These considerations outline how the researcher plans to

conduct the study responsibly, especially in dealing with sensitive international or political issues.

13. Organization of the Study

It will outline how the research project will be structured. It provides a roadmap for the reader, showing how the study will be divided into sections or chapters and what each will address. All chapters will be aligned with the respective questions.
